WHEREAS, Peter E. Henry, Esq., of the firm McElroy, Deutsch, Mulvaney & Carpenter, LLP, has submitted a proposal indicating that he may provide legal services for 2018 in an amount projected to exceed \$17,500 (including escrows); and

WHEREAS, the anticipated term of this contract is one (1) year; and

WHEREAS, Peter E. Henry, Esq., of the firm McElroy, Deutsch, Mulvaney & Carpenter, LLP, has completed and submitted a Business Entity Disclosure Certification which certifies that he has not made any reportable contributions to a political or candidate committee of the Borough Council in the Borough of Mendham in the previous one (1) year, and that the contract will prohibit him from making any reportable contributions through the term of the contract; and

WHEREAS, this resolution is subject to the Chief Financial Officer certifying to the availability of funds; and

WHEREAS, the Planning Board of the Borough of Mendham wishes to retain Peter E. Henry, Esq. of the firm McElroy, Deutsch, Mulvaney & Carpenter, LLP; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires that the Resolution authorizing the award of contracts for "professional services" without competitive bids and the contract itself must be available for public inspection.

NOW THEREFORE, BE IT RESOLVED by the Planning Board of the Borough of Mendham as follows:

- 1. That the Planning Board of the Borough of Mendham retain Peter E. This contract is awarded without competitive bidding as a "professional service" in accordance with N.J.S.A. 40A:11-5(1)(a) of the Local Public Contracts Law because said services are exempt from the provisions of the bidding statutes in that they are services rendered or performed by a person authorized by law to practice a recognized profession and are services which require knowledge of an advanced type in a field of learning acquired by a prolonged course of specialized instruction as distinguished from general academic instruction or apprenticeship and training.
- 3. The Business Disclosure Entity Certification and the Determination of Value shall be placed on file with this resolution.
- 4. That a notice of this action shall be published once in the official newspapers of the Planning Board of the Borough of Mendham, as required by N.J.S.A. 40A:11-5(1)(a).

WHEREAS, this resolution is subject to the Chief Financial Officer certifying to the availability of funds; and

WHEREAS, the Planning Board of the Borough of Mendham wishes to retain Paul W. Ferriero; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires that the Resolution authorizing the award of contracts for "professional services" without competitive bids and the contract itself must be available for public inspection.

APPLICATION FOR EXTENSION

PB #943 Barber, 78 Mountainside Road

Block 501, Lot 24, Minor Subdivision Approved December 14, 2015

Present: Mr. Luke Nikander, Office of John M. Mills, III, Attorney

Mr. Christopher Nusser, Engineer

Mr. Nusser was sworn. Mr. Nusser explained that since the property is outside of the sewer service area and connecting to the sanitary sewer of the Borough, the New Jersey state sanitary sewer maps needed to be modified. He also mentioned that there does not exist a statuary limitation on the time for the state to act, and that the draft Preliminary Notice is completed. However, the extension would give the NJ Department of Environmental Protection (DEP) an opportunity to review and publish the final Notice. Mr. Henry stated that the maximum extension the Board would be able to grant would be one year from December 14, 2017, which is two years from the Memorialization of the Resolution for this application. Mr. Nusser felt they would need the full year extension.

Mr. Ferreiro stated that the one-year extension was reasonable, however he felt that revised engineering plans should be submitted within 30 days of the initial publication by the NJ DEP. Mr. Henry recommended that there should be a "check in" date by the applicant's attorney to update the Board on their progress.

Ms. Lichtenberger made a motion to approve the extension request with the specified conditions, and Councilman Sharkey seconded the motion.
