# ADMINISTRATOR'S REPORT

Ms. Bushman provided a copy of her Administrator's Report dated October 9, 2019 to the Mayor and Council. She reported that American Water's contractor has modified its work schedule on Talmage Road for the coming week. The change of schedule has been posted on the website. Ms. Bushman also distributed a copy of the updated phone matrix, which she mentioned will go into effect as soon as the phone audit has been completed at the end of the month.

Council Member Reilly reported that he will be working with the Borough's IT service provider to set up a share drive on the Borough's network for the ECOOST working groups.

Council Member Reilly also informed the governing body that Morris County confirmed it will be taking over the maintenance of Patriot's Path from the mud hole to the Water Reclamation Facility. A transfer of the easement from the Borough to the county would need to be recorded.

There was no further Council discussion concerning the Administrator's Report.

# **COUNCIL COMMITTEE REPORTS**

# Finance [Standing Committee of the Council]

Council Member Badal reported that two grant writers have been contacted for proposals. He also reported that the 2020 budget process will begin shortly with the submission of department budget requests.

#### **Board of Health**

Council Member Andrew reported that the Board of Health cancelled its October meeting. The next scheduled meeting will be held on November 6<sup>th</sup>. He further reported that The Bernardsville Department of Health will be providing flu shots at the Mendham Area Senior Housing on October 10<sup>th</sup>.

# **Recreation and Parks [Standing Committee of the Council]**

Council Member Andrew reported that the Recreation Committee will be meeting next week and had nothing new to report.

# **Board of Education**

Council Member Andrew reported that the next scheduled meeting of the Mendham Borough Board of Education is scheduled for October 28<sup>th</sup>.

Council Member Andrew also reported that West Morris Regional School District Board of Education held its meeting on October 8<sup>th</sup> and mentioned that the Superintendent's contract was renewed.

# **Public Safety [Standing Committee of the Council]**

Council Member Andrews thanked Mayor Serrano-Glassner for promoting the Borough's upcoming Veterans Day Celebration scheduled for November 8<sup>th</sup> at the Pastime Club. He then reported that the drainage project on East Main Street at the Rowe Sheep Farm has been completed and also reported that American Water's water main replacement project is continuing on Talmage Road. Council Member Andrews also briefly reported on the Public Safety Committee's September 25<sup>th</sup> meeting with Dean Road residents. Residents will be petitioning the committee to consider reducing the speed limit on Dean Road to 25 MPH.

Council Member Andrews further reported that the Office of Emergency Management held its meeting on October 30<sup>th</sup>. The Borough's eligibility for FEMA grant funding was discussed. The Borough Administrator has been asked to send a letter of interest to the county. Lastly, he reported that the five AED defibrillators have been received and will be mounted and installed by the DPW shortly.

# **Personnel [Standing Committee of the Council]**

Council President Sharkey reported that the Borough's annual Fall Foliage Photo Contest has begun. The resident who submits the best picture of a Borough street tree will win a tree to be planted along a Mendham Borough street. The contest ends November 15<sup>th</sup>.

Council President Sharkey also reported that the Personnel Committee will meet next week. Several personnel issues are under review.

# **Public Works and Utilities [Standing Committee of the Council]**

Council Member Kelly reported that the DPW Superintendent has requested quotes for the replacement of the Firehouse garage doors and also reported that the lease terms for the renewal of the Petsch House lease is being negotiated.

# Land Use [Standing Committee of the Council]

Council Member Reilly had nothing new to report.

# **ECOSST Committee**

Council Member Reilly reported the ECOSST Committee has restructured the Environmental Technical Review checklist, which will help determine whether an application before the Planning Board would require an environmental impact study. He also reported that members will be walking the Scott Farm property with Chris Neff of the Audubon Society to determine possible options for the use, conservation or preservation of the property. Lastly, he reported that a Mendham Township property owner dug a trench from India Brook to a pond that is located on the property. The NJDEP has been notified. The ECOSST Committee will be researching mechanisms that can be enacted to help protect Class I streams and waterways.

# **MAYOR'S ITEMS**

Mayor Serrano-Glassner asked the Council to review the *Guide to Attending a Mayor & Council Meeting* prepared by the Borough Clerk. Once finalized the guide will be made available to the public. She also reported that the monthly edition of the *Mendham Messenger* limits the Mayor's Update to 500 words. Going forward, future articles may refer the reader to the Borough's website for the full article.

Mayor Serrano-Glassner also reported that a social media policy will be drafted for the Borough, which elected officials, appointed officials, volunteers and employees of the Borough would be required to follow. Lastly, she asked the Council to begin planning regular scheduled meetings for their respective Standing Committees of the Council for the coming year.

# **PUBLIC COMMENT – AUDIENCE PARTICIPATION:**

Mayor Serrano-Glassner opened the meeting for public comment and invited any member of the public to be heard.

Laura Montenegro, 8 Linden Lane, inquired about the state's initiative to consolidate K-4 to K-8 school districts throughout the state. She asked if there have been any discussions between state and Borough officials regarding the consolidation of the Mendham Borough school district. Mayor Serrano-Glassner responded that there have been no discussions between state and Borough officials.

Mary Sue Martin, 35 Mountain Avenue, suggested St. Marks as an alternate venue for the Borough's Veteran Day Celebration in the event the Pastime Club's venue is not large enough to accommodate the number of people attending. She will confirm availability with St. Marks.

Seeing no one wishing to speak, Mayor Serrano-Glassner closed public comment and proceeded with the next agenda item.
