CALL TO ORDER

Mayor Henry called the October 19, 2017 regular meeting of the Mayor and Council to order at 8:04PM in the Garabrant Center, 4 Wilson Street, Mendham, New Jersey.

INVOCATION AND FLAG SALUTE

Mayor Henry led a moment of silent meditation followed by the Pledge of Allegiance.

DISCUSSION

Doubleday Family Celebration: Charles Topping

Mr. Topping discussed the accomplishments of Abner Doubleday and stated that he was perhaps Mendham's most well-known resident. He indicated that Mr. Doubleday was born on June 19, 1819 and suggested a bicentennial celebration to honor him. Mr. Topping requested that a committee be appointed to research such areas as:

- Education/scholarship opportunities
- Mendham Township partnership
- Newspaper publicity
- Obituaries for Mr. Doubleday and his wife
- Presbyterian Church records

Mayor Henry agreed to appoint a committee as long as Mr. Topping agreed to attend the celebration. He then read a proclamation recognizing Mr. Topping's contributions to the community. Councilman Andrus further thanked Mr. Topping for all his efforts in the Borough and presented him with a gift. Mr. Topping thanked the Mayor and Council.

Curbside Collection of Recycling Bid

Mayor Henry announced that Blue Diamond submitted the only response to the recent request for recycling bids which included an 82% price increase. He listed Blue Diamond's reasons for the increase (calculation error on prior bid, required manpower, market conditions) and instructed that Council may either accept the bid or consider an interlocal agreement with East Hanover or Mt. Olive Townships. Mr. Semrau added that the Council may also reject bid as over-budget and re-bid in the future.

There was consensus that a possible interlocal agreement be explored.

Vehicular and Pedestrian Traffic

Councilman Andrews stated that the Public Safety Committee is recommending the installation of button-activated LED signage at the intersections of Main and Halstead and Main and Tempe Wick that will alert drivers to pedestrians in the roadway. Mayor Henry agreed to request the necessary funding from the county. Councilman Andrus stated that any remaining amounts will have to be budgeted for 2018.

ADMINISTRATOR REPORT

COUNCIL REPORTS, OLD & NEW BUSINESS

<u>Councilman Andrews</u> – DPW employees are receiving CPR and CEVO training in order to back up MFAS and drive ambulances, if necessary; recruiting efforts continue. Beginning 2018, all reporting to the New Jersey Department of Health must be done electronically which will result in additional expenditures for equipment, software and training. MFD participated in a compressed natural gas training session. The Garabrant Center backup generator went out to bid and is due November 8, 2017. Joint PD initiatives continue with a Toys for Tots drive for the Marine Corps Reserve.

<u>Councilman Andrus</u> – Budget packets are due by October 31, 2017. Meetings will be held with each department head in advance of the December budget meeting with the full Council.

<u>Councilman Badal</u> – DPW continues to mow and pickup brush and snow plows and salt spreaders have been readied for winter. Five (5) DPW employees attended a protection safety class. Rotted posts at Tranquility Garden were replaced.

<u>Councilwoman Glassner</u> – Interviews have been scheduled for the new Administrator. A parttime staff member has requested full-time employment. Mayor Henry opined that outsourcing the management of police details would significantly reduce the staff workload; the Personnel Committee will research the options. A meeting to discuss the West Field pavilion will be scheduled. The Washington Post has ranked WMMHS the no. 4 high school in New Jersey.

<u>Councilman Sharkey</u> – The Shade Tree Commission is working with the DPW to plant various trees around the Borough. The Environmental Commission is recommending parking and other improvements to Tranquility Garden; however, it was agreed that Tranquility Garden is a "pocket park" and not intended for improvements. It is recommended that the Mayor and Council consider aerating the Mountain Valley Park dam as it is an inexpensive way to maintain water quality; Councilman Badal suggested a quote from Princeton Hydro. Council Witczak proposed illuminating the island to deter Canada geese.

Councilman Witczak – The ITZ is suspended from field use due to an improper application; they may reapply in 2018. The Recreation Committee has discussed a year-long Doubleday celebration with a Father's Day weekend kick-off followed by various themed events and culminating in a celebration in June 2019. Suggested events include movie night, concert series, food truck event and monetary rewards to students who unearth significant facts and information. The Recreation Committee will continue to work on the proposal.

MAYOR'S ITEMS

Mayor Henry stated that there has been a tremendous response to the Local Economic Development initiative however there are concerns regarding change in ownership of local businesses. Mr. Semrau proposed an ordinance that would simplify the change in ownership process in instances where the use remains essentially the same. He confirmed that the ordinance may be introduced by title tonight and then referred to the Planning Board for consideration. Public hearing will be during the November 16, 2017 Council meeting.

PUBLIC COMMENT

Mayor Henry opened the floor to comments/questions from the public and advised that comments must be kept to five (5) minutes.

Mrs. Patricia Serrano, 34 Maple Avenue, stated that there exists an article from a 1950 publication that contains a photo of the Doubleday's Hilltop Road property where a commemorative plaque was installed. Mrs. Serrano agreed to try to locate the article.

Mrs. Alice Bouchie, 20 West Main Street, proposed that the Doubleday kick-off event correspond with Little League opening day. She further expressed her opposition to the Dunkin Donuts signage on Main Street as her property value has decreased and she is being harmed as a result. Mayor Henry agreed that a number of complaints have been received and Mr. Semrau issued the following opinion:

- 1. Expression of free speech is permitted within the boundaries of private property as long as there are no safety concerns
- The Borough cannot compel residents to remove the signage and can only ask if they are necessary as it is an aesthetic issue at this time and no application has been filed
- 3. The Borough may have more leeway on signs displayed on public property

Mrs. Bouchie reiterated that the signage is detracting from the Borough and lowering property

Mr. Brennan Reilly, 14 New Street, expressed his support for ordinance no. 11-17. He stated that he is a member of the Board of Adjustment and asked that the LED Committee review the parameters surrounding the transfer of a variance to a new property owner when the variance does not adhere to the Master Plan.

Mr. Peter Pfaffenroth, Attorney for Frank's Pizza, stated that the pizzeria would be a good addition to the Village Shopping Center and opined that the process to allow new businesses should be simplified. He requested that his client's sanitary sewer allocation be recalculated and the payment procedure reviewed.

Hearing no additional comments, Mayor Henry closed the public portion of the meeting.
