ADMINISTRATOR'S REPORT

Ms. Bushman provided a copy of her Administrator's Report dated November 13, 2019 to the Mayor and Council. She reported that the Recreation Department will be hosting Mendham's 2nd Annual Holiday Home Decorating Contest. Prizes will be awarded to the top three chosen homes. Forms and information is posted on the website's Form Center under Recreation. She also reported that the Mendham Business Association will be holding its annual Holly Trail Events next month. A new event this year will include cookies and photos with Santa at the Phoenix House. Information is posted on the website.

Council President Sharkey inquired about the implementation of the on-line tax and sewer utility payment module and also questioned the status of appointing a Tax Collector. Ms. Bushman responded that the delay in the implementation of on-line payments was due to needed technology updates. She also reported that the Tax Collector position will be advertised in January 2020.

Finance [Standing Committee of the Council]

Board of Health

Council Member Andrew reported that the next meeting of the Board of Health will be held on December 5th. He further reported on upcoming public programs sponsored by the Bernardsville Department of Health. Upcoming programs are posted on the Board of Health webpage.

Recreation and Parks [Standing Committee of the Council]

Council Member Andrew reported that the Recreation Committee will be meeting on November 21st. Topics to be discussed include the tennis court rehabilitation project and a proposal for an outdoor winter ice rink.

Board of Education

Council Member Andrew reported on the West Morris Regional School District's unification program. He also congratulated the West Morris Girls Soccer team for winning the state tournament.

Public Safety [Standing Committee of the Council]

Council Member Andrews reported that the Veterans Celebration held on November 8th at the Pastime Club was attended by 35 veterans and thanked those that assisted in the event. He further reported that the Public Safety Committee and the Police Chief will be available to meet with residents at 7:00 p.m. the second Wednesday of the month before the commencement of the Mayor & Council meeting. Council Member Andrews confirmed that the Department of Public Works had posted deer management signs outside the park entrances to notify the public that deer hunting activities are allowed. He also confirmed that the Talmage Road water main replacement project has been completed and that the Police Chief has issued letters to the Orchard Street residents concerning the on-street parking ordinance. Lastly, Council Member Andrews reported that the next OEM meeting is scheduled for November 18th and reminded everyone that the Police Department will be a collection point for the annual Toys 4 Tots ® toy drive.

Personnel [Standing Committee of the Council]

Council President Sharkey reported that the Personnel Committee has been meeting with the Administrator on several personnel issues. He thanked the Department of Public Works for the fall planting of shade trees and also for their on-going efforts in maintaining Mendham Borough's Tree City, U.S.A.® designation.

Public Works and Utilities [Standing Committee of the Council]

Council Member Kelly reported that the DPW Superintendent requested quotes for the replacement of the Firehouse garage doors and also reported that repairs have been made to the Knollwood trail bridge. Council Member Kelly further reported that the Public Works Department has taken delivery of road salt in preparation for the winter season.

Land Use [Standing Committee of the Council]

Council Member Reilly was absent.

ECOSST Committee

Council President Sharkey reported that the committee is looking into the National Wildlife Foundation's Community Wildlife Habitat designation program, which promotes wildlife-friendly practices in communities through the use of native trees and plants.

ATTORNEY'S ITEMS

Mr. Semrau advised that \$5.9 million in added assessments have been processed by the Assessor as a result of construction permits that have been closed by the Building Department. He further confirmed that he will schedule a 1-hour Municipal Excess Liability Joint Insurance Fund (MEL) seminar on the recent legislative changes affecting molestation claims to allow an opportunity for elected officials to attend. Elected officials attending the seminar earn a \$250 credit towards the town's MEL premium.

MAYOR'S ITEMS

Mayor Serrano-Glassner reported that a resident had inquired if the Borough would be securing the tennis courts once construction is completed and they are open for public use. The Administrator was asked to look into options to secure access to the tennis courts.

Selection of Labor Day Parade Grand Marshall [§4-12.2 of the Borough Code]

Mayor Serrano-Glassner began the process of soliciting nominations from the Borough Council for the selection of the 2020 Labor Day Parade Grand Marshall. She asked that nominations be submitted to the Borough Clerk with a brief summary highlighting the person's contribution to the Borough. The Borough Clerk will compile a listing of nominations for future Council consideration in accordance with §4-12.2 of the Borough Code.
