# **ADMINISTRATOR REPORT**

## **COUNCIL REPORTS, OLD & NEW BUSINESS**

Councilman Andrews – Five (5) members of the DPW received CPR training with four (4) others scheduled for November 30<sup>th</sup>. Ambulance driver training will be conducted at no cost to the Borough. The scheduled EMR class has been postponed to January with two (2) police officers and three (3) new MFAS members scheduled to participate. Phase 2 of the firehouse renovation has begun. The OEM Coordinator is seeking additional funding for the Garabrant Center emergency generator since the lowest bid was over budget. Mr. Semrau stated that it may be possible to amend the grant amount in order to cover the bid costs. A conference call is scheduled for November 22, 2017 to discuss same.

<u>Councilman Andrus</u> – The preliminary budget is 152K above the 2% cap (including repayment of the 80K dam project loan) so reductions must be found. Pension and health insurance increases are well over 2%. Capital requests are up but cap money may be available. Meetings will be held with Department Heads prior to the budget meeting with the full Council.

<u>Councilman Badal</u> – The DEP has planted 27 trees in accordance with Councilman Sharkey's recommendations. Carbon dioxide detectors have been installed in Borough buildings. A PEOSHA

inspection has determined that the Borough is in compliance. 1000 cubic yards of silt were removed from the dam. Doug Wright was recognized as Superintendent/Director of Year.

Councilwoman Glassner - excused.

<u>Councilman Sharkey</u> – The Planning Board approved the Ketchum subdivision. Dunkin Donuts has not filed a new application. Three (3) candidates are being considered for the Administrator position and 2<sup>nd</sup> round interviews will be held on December 7<sup>th</sup> beginning at 5PM. The Canning Group will notify the candidates.

<u>Councilman Witczak</u> – Holly Trail is scheduled for December 2<sup>nd</sup> and all are encouraged to participate and support the Recreation Department.

#### **ATTORNEY ITEMS**

Mr. Semrau announced that Judge Nergaard has ordered all participating municipalities to contribute \$5K for the services of Richard Reading who has been appointed the Affordable Housing Special Master. Mr. Reading will look at the current figures and develop his own fair share numbers.

### **MAYOR'S ITEMS**

Mayor Henry requested that he be updated on any Board/Commission/Committee vacancies. He confirmed that Administrator interviews will be conducted in closed session.

#### **PUBLIC COMMENT**

Mayor Henry opened the floor to comments/questions from the public and advised that comments must be kept to five (5) minutes.

Mr. Ronald Weissman, 15 Tempe Wick Road, requested an update on infrastructure deficiencies he alleged during a previous meeting. Councilman Badal advised that the DPW Superintendent and Borough Engineer are visiting the various sites and will provide feedback once the review is completed. Mr. Weissman stated that he had seen heavy trucks on Bliss Road. He further requested that the Borough reconsider its flag-lowering policy and follow the orders of the President rather than the Governor. Mayor Henry stated that the Borough will continue with its current policy.

Hearing no additional comments, Mayor Henry closed the public portion of the meeting.
