Councilman Badal - The Land Use Committee met on December 15, 2016 to discuss the following:

- 1. High School Signage Mr. Merkt has agreed to contact the Superintendent to discuss placement of one (1) larger sign that can accommodate multiple announcements.
- 2. Grand Opening Banners (Village Shopping Center) Ms. Sullivan will confirm whether an ordinance is required in order to permit new store signage (30 sq. ft. maximum) to be affixed to the building only for a two (2) week period. All grand opening signage is to be reported to the Administrator for Zoning Officer inspection.
- 3. Sandwich Board Signage The ordinance permits one (1) per lot, therefore, multiple boards in the Village Shopping Center is a violation. The Zoning Officer will notify the tenants as a courtesy and then remove any non-compliant signage.

Councilwoman Daly - no report.

<u>Councilman Sharkey</u> – Approximately 200 trees have been planted in the Borough over the last ten (10) years. The DPW does a great job with the seedlings received from the state and now maintains a nursery on DPW property. Holly Trail had the largest attendance to date.

Councilman Sharkey thanked Borough residents for the opportunity to serve a third term and stated that his efforts will focus on planting additional trees, increasing the number of tree promotion events and working with the Environmental Commission to publicize Earth Day.

<u>Councilman Witczak</u> – Councilman Witczak thanked the Council for their approval of two (2) DPW new hires.

<u>Councilman Andrus</u> – Councilman Andrus thanked Councilwoman Daly for her six (6) years of service to the Council and expressed sorrow at seeing her step down.
