ADMINISTRATOR REPORT

Mr. Merkt confirmed that the Talmage Road re-bid came in at \$368K which is \$71K less than the initial bid and asked that the Council authorize funding for both the Talmage Road and Orchard Street paving projects. He further reminded the Mayor and Council to be cognizant of the contract award timeline as it relates to the 2016 budget adoption and the May award deadline to ensure grant funding for both projects.

Mr. Merkt indicated that a Zoning Officer candidate will be invited back the following week. Potential part-time Police Secretary candidates have been identified and will be invited in for initial interviews. Police accreditation is scheduled for April 10-11, 2016 and the Mendies will be held on March 11, 2016.

COUNCIL REPORTS, OLD & NEW BUSINESS

Councilman Andrews – An offer to the Zoning Officer candidate should be extended before the next Council meeting and the Land Use Committee continues to refine the Outdoor Dining ordinance. In response to Councilman Sharkey's request for an update on the Sisters of Christian Charity Planning Board hearing, Council Andrews stated that the hearing was continued to March 14th and confirmed that the zoning ordinance adopted in late 2015 will safeguard against any improper usage of the existing Motherhouse.

Councilman Badal - excused.

Councilwoman Daly – The Public Safety Committee met in person and via telephone to discuss the Matrix report with a final meeting scheduled for March 14, 2016 at 5PM. Mr. Merkt will subsequently write a report setting forth recommendations to be distributed in the next meeting packet. The Public Safety Committee will focus on the Borough Safety Plan next.

Councilman Sharkey – A Grand Marshal for the 2016 Labor Day parade will be selected prior to the next Council meeting.

MAYOR'S ITEMS

Mayor Henry explained that Mr. Semrau was not present at the meeting due to a speaking engagement at the Governance & Leadership Conference in Nashville. He congratulated Mr. Semrau for receiving an invitation from the Association of Group Insurance Pools to address a national audience and agreed that such recognition is well deserved.

In response to resident feedback, Mayor Henry asked that Council and Board agendas and minutes be posted timely on the Borough website. A special public meeting to discuss the Feasibility Study has been tentatively scheduled for April 4, 2016 at 7PM. Mayor Henry recommended that the Council watch Mr. Haber's presentation of the report on Mendham TV. Ms. Kaye will distribute instructions to access the video link.

PUBLIC COMMENT

Mayor Henry opened the floor to comments/questions from the public.

Mr. Charles Topping, Aberdeen Drive, presented a set of Sanborn maps from the 1930s that were found in the Land Use file room. He indicated that the canvass-backed maps depict Mendham Borough's town center and surrounding areas. He requested use of the maps for his upcoming presentation to the Senior Center which was granted. Mr. Topping further suggested that a second set of maps in very delicate condition be restored, framed and displayed during the Borough's $110^{\rm th}$ anniversary on May 15, 2016. He added that Richard Moormann has offered to do the work at cost (\$800).

Councilman Andrews made motion to approve the requested funding for restoration and preservation of the second set of maps.
