# **ADMINISTRATOR REPORT:**

The Council President referred the Council to the Administrator's report in her absence that was submitted prior to this meeting.

# **COUNCIL REPORTS, OLD & NEW BUSINESS:**

Councilman Badal thanked the police, fire, first aid and the department of public works for their response to hurricane "Irene" and its effects. He announced that there will be a public safety meeting held this Thursday.

It was noted that Police Chief Taylor kept the overtime for his department down to \$3,200 during and after the hurricane. These expenses can be submitted to FEMA for reimbursement. The FEMA paperwork will be filed with the Borough'

Councilman Witczak likewise thanked his departments, Public Works and the Water Reclamation Facility employees for all their assistance during and after the storm.

It was noted by Councilman Witczak that Superintendent Ken O'Brien has informed him that there are some large trees that will have to taken down once the weather dries out, the paving

projects have been pushed to Friday (weather permitting) and the field damage can be handled in-house by the DPW. It was further noted that Mountainside Road was still without power.

Councilman Andrus will schedule a finance committee meeting to discuss capital project funding specifically the basketball and tennis court rehabilitation. Recreation Director Bruce DiBisceglie reported that cushions for the poles and nets have been purchased for the basketball court. Councilman Andrus will ask DPW Superintendent Ken O'Brien to puts some weed killer down on the tennis courts.

Councilman Sharkey reported that the sign ordinance is still a work in progress. Our Borough's planner Charles McGroarty has reviewed the draft ordinance and has made constructive suggestions which have been implemented.

Councilman Garubo on the well planned arrangements made for the Labor Day parade and the repair work needed at both the basketball and tennis courts.

It was noted that the fireworks where set off earlier than expected due to the short window of time caused by the weather conditions. Once the charges are loaded, they cannot be unloaded, and for safety reasons need to be fired. There was discussion with regard to who would render the final decision with regard to safety and the fireworks. Atty. Breem will report back to the Council after researching the answer to this question.

#### **ATTORNEY ITEMS:**

Atty. Breem reported that Atty. Semrau will discuss the Comcast franchise agreement in closed session at the next meeting. He further mentioned that the Borough Engineer Paul Ferriero will have a sanitary sewer allocation update shortly for the governing body.

Police Chief Taylor asked if during the franchise agreement discussions, service to the municipal offices could be negotiated for no charge.

**MAYOR'S ITEMS**: Mayor Henry was not present at this meeting.

**PUBLIC COMMENT:** There were no public comments made.
