ADMINISTRATOR REPORT:

Administrator Sandman commented that a sewer adjustment for seniors will be discussed at the committee level as soon as possible and the results will be addressed at the next Council meeting. Ms. Sandman noted that the Borough Attorney will address the pavement assessment program in regard to Bridge Street and the budget meeting dates were confirmed but the location for the December meeting will be made firm after checking with the availability of the Fire House meeting room.

Councilman Andrus requested that the Finance Committee meet prior to the first budget meeting for a review of questions and concerns.

Administrator Sandman announced that our Health Officer, Lucy Forgione reported that the H1N1 vaccine will be given to Fire, Police and EMS workers this Wednesday.

COUNCIL REPORTS, OLD & NEW BUSINESS:

Councilman Garubo reported concerns expressed by residents Peter and Charles Rowe who own and operate a working farm located at 63 East Main Street on the introduction and of Ordinance #14-09. This ordinance amends the Historic District Overlay Zone to include their property. Administrator Sandman responded that they were presently attending the Historic Preservation meeting at the Phoenix House and will be here by the public portion of this meeting to speak.

Councilman Andrus thanked CFO Sue Giordano for the additional explanations of items on the bill list. He questioned a voucher for police equipment and the date it was signed by the vendor. Administrator Sandman explained that the work on the police cars was delayed but would obtain the information requested and get back to Councilman Andrus. A request was made by the Council to hold payment until the usual net 30 days.

Councilman Murphy reported that interviews for a new police officer will be held in executive session at the next two meeting. He further recommended that due to a recent request to use the Fire House and subsequent conflict, that this location be included in the facility use procedure in place for other Borough locations.

ATTORNEY ITEMS:

Atty. Semrau reported that a letter of explanation regarding the Historic District change will be sent by the Mayor and the preparing of a sewer allocation ordinance for introduction.

Administrator Sandman introduced and requested Mr. Chris Loeber, 3 Bridge Street for a short overview of the conditions of this street. Mr. Loeber reported that this is a private unimproved road. The Borough does snow plow and fill in potholes on this road. He further reported that the grading is thin; gravel is gone and when it rains it makes craters in the road.

Atty. Semrau explained that a letter to all the residents on this road would be sent to obtain whether or not there is an interest in improving the road. The residents can enter into a private contract and seek assistance from the Borough. A survey and bid spec preparation to improve the road to Borough standards would also be a cost to the residents. A second approach would be for the Borough to do the work and assume responsibility for the road and place a 10 year added assessment to the properties located on this street.

Council President Andrus concluded that Mr. Loeber talk to his neighbors about the options discussed. He further requested that the Public Works Committee discuss and the Borough Engineer visit the site and come up with a temporary resolution and report back to Mr. Loeber.

MAYOR'S ITEMS: Mayor was not present at this meeting.

PUBLIC COMMENT:

Craig Bellamy, 6 Garabrant Street, commented that the Fire Department did not deny the use of the Fire House for a blood drive for a Borough child, they suggested that it be combined with a previously scheduled one being sponsored by the Junior Women's Club.

Barbara Nelson, 16 Horseshoe Bend Road, reported on the cancellation of seasonal flu clinics. Administrator Sandman commented that she will contact Lucy Forgione for updates on availability and scheduling for both the seasonal and H1N1 flu.

Peter Rowe and Charles Rowe, 63 East Main Street, repeated the concerns expressed earlier by Councilman Garubo regarding the pending ordinance (#14-09) amending the Historic District Overlay Zone to include their property. They attended the Historic Preservation Committee meeting where their concerns were discussed to their satisfaction. Their major concern was the impact this ordinance would have on their maintaining their farm and doing business.
