**RESOLUTION #037-2025**

**RESOLUTION AUTHORIZING THE SALE OF A 1999 PEIRCE DASH PUMPER AND A 2003  
PIERCE DASH RESCUE FIRE TRUCKS THAT ARE NO LONGER NEEDED FOR MUNICIPAL  
PURPOSES TO OFFSET THE COST OF THE PURCHASE OF A NEW FERRARA CINDER PUMPER  
RESUCUE FIRE TRUCK PURCHASE**

**WHEREAS**, the Borough of Mendham is the owner of two fire trucks, a 1999 Pierce Dash Pumper (VIN# 4P1CT0250XA000948) and a 2003 Pierce Dash Rescue (VIN # 4P1CT02H23A003091), that are no longer needed for municipal purposes; and

**WHEREAS**, the Borough has determined that the Mendham Fire Department can sell the trucks through a private sale at a significantly higher price than the Borough can obtain by auctioning the trucks off pursuant to the Local Land and Buildings Law; and

**WHEREAS**, Borough wishes to sell the fire trucks to the Mendham Independent Hook and Ladder Co., a registered 501(c)(3) public charity, for nominal consideration so that the Borough Fire Department can sell the fire trucks and all proceeds from the sale of the fire trucks will be used to offset the cost of a new Ferrara Cinder Pumper/Rescue fire truck to be purchased by the Borough; and

**WHEREAS**, pursuant to N.J.S.A. 40A:12-21.1, the Borough is authorized to sell personal property no longer needed for municipal purposes to certain organizations, including volunteer fire departments, for nominal consideration, with certain conditions; and

**WHEREAS**, the Mendham Independent Hook and Ladder Co., has agreed to purchase the fire trucks from the Borough; and

**WHREAS**, the Finance Committee of Council has reviewed and recommended the sale; and

**WHEREAS**, the Mayor and Council have determined that it is in the best interest of the Borough to convey the title to the Fire Trucks to the Mendham Fire Department for \$1.00.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Mendham, County of Morris, State of New Jersey,

- 1) That the conveyance of title for a 1999 Pierce Dash Pumper (VIN# 4P1CT0250XA000948) and a 2003 Pierce Dash Rescue (VIN # 4P1CT02H23A003091), to the Mendham Independent Hook and Ladder Co., for \$1.00 is hereby authorized.
- 2) The Mendham Independent Hook and Ladder Co., hereby agrees to use all proceeds

from the sale of the fire trucks to offset the cost of the purchase of a new Ferrara Cinder Pumper/Rescue fire truck.

This resolution shall take effect immediately.
