8. COUNCIL REPORTS

Recreation and Parks/School Boards Liaison -

Matthew Bruin

The chair reported that Recreation is currently hiring camp counselors and an assistant director for the 2025 Mendham Borough Day camp.

The Summer Concert Series bands are booked with new talent for Summer 2025.

The Recreation coordinator is working on finalizing the booklet and updating our facilities booking system. Residents will be able to reserve facilities on our webpage.

The Chair also reported that he attended the West Morris School Board meeting and introduced himself to the Board as the School Board Liaison. He plans on doing a walkthrough of the Mendham Borough schools.

Council members Bruin and Henry Traut met with all the departments in the town to see "behind the scenes" of the operations of the town.

Public Safety- Chair Marilyn Althoff

The Chair reported that there has been a recent increase in concern over pedestrian safety, working to get more see-me flags at crosswalks. She also reported that the Borough engineer and the county are working on an ongoing evaluation at Hilltop and Route 24 traffic lights and lighting issues.

The Officer in Charge reported that there are three officers retiring. The Borough offered conditional employment offers to two officers graduating from the Academy in June. And waiting to hear back from a third new hire.

The chair reported that the Personnel Committee met last week to discuss employee evaluations. Evaluations should be completed by the end of March.

9. ATTORNEY'S REPORT

Borough attorney Fred Semrau reported that Mayor Serrano Glassner resigned on February 6th. He has been working with the administration and the Borough Clerk to follow the procedure to fill the Mayor's vacancy. As of February 6th, the office is vacant. The Council President will, in the interim, act as Mayor. The Republican Committee will meet to pick three names for the Council to decide at a public meeting which candidate it chooses to fill the vacancy.

10. PUBLIC COMMENTS

Ryan Mullany, 6 Prospect Street, and Matthew Stated he recently got hit by a car while crossing Main St. Matthew read a series of questions addressed to the Council regarding safety, traffic violations, crossing guards, speed limits, and traffic study results. Council President Sullivan referred to Sergeant McNichol to help answer questions. Sergeant McNichol answered all the questions that he could and offered to email specific statistical answers to Matthew. The council agreed to have the Public Safety Committee meet and discuss this issue.

Bob Ritger, 14 Gunther St, asked: Is it accurate that the Council adopted a resolution for 115 affordable units instead of the 133 units assessed by the State? Council President Sullivan stated that is correct. The Borough did their calculations and found 115 to be the number. He also asked what happens when there is a vote, and it is a tie with only six Council members. The Borough attorney stated that it would not carry if there was a tie vote.

Margaret Burke, of 8 Bockhoven Rd, stated she was very close to being hit while crossing at a crosswalk with flashing lights. She said that nothing will change until we start making people pay. More summons needed to be issued.

Henry Niemczyk, 55 Dean Rd said he had come before the Council in the past to complain about speeding on Dean Rd. He stated that nothing had changed. He also stated that people are not shoveling their sidewalks. If we issue more tickets, that's how change will happen. David Sergio, 15 Demarest Drive, stated that he would like to commend Matthew for advocating

for himself and his Mom.
