RESOLUTION AUTHORIZING THE GENERAL CAPITAL FUND PURCHASE AS AUTHORIZED BY ORDINANCE #06-2024 OF A 2024 FORD SUPER DUTY F-550 TRUCK CHASSIS DUMP TRUCK BODY, PLOW AND RELATED EQUIPMENT THROUGH THE ESCNJ COOPERATIVE PURCHASING PROGRAM

WHEREAS, the Borough of Mendham has a need for a dump body, plow, and related equipment for a 2024 Ford Super Duty F-550 truck chassis being purchased by the Borough for the Department of Public Works; and

WHEREAS, N.J.S.A. 52:34-6.2 authorizes municipalities to purchase goods or services through cooperating purchasing programs in lieu of public bidding; and

WHEREAS, through Educational Service Commission of New Jersey ("ESC") Cooperative Purchasing Program Contract #65MCESCCPS – ESCNJ 23/24-04, the DPW Superintendent has obtained the attached quote dated February 15, 2024 from Reed Systems, Ltd in the amount of \$67,412.43 for the dump body, plow, and related equipment; and

WHEREAS, the Borough Finance Committee has reviewed and recommend the purchase as part of the 2024 budgeting process; and

WHEREAS, the purchase of the equipment will be funded by the Borough General Capital Fund, as authorized by Ordinance #06-2024; and

WHEREAS, the Borough's Chief Financial Officer has certified that sufficient funds are available for this purpose.

THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Mendham, in the County of Morris and State of New Jersey, as follows:

- 1. The Borough is hereby authorized to purchase a dump body, plow, and related equipment for a 2024 Ford Super Duty F-550 truck, in the amount of \$67,412.43, from Reed Systems, Ltd, 17 Edwards Pl, Ellenville, NY 12428, through ESC Cooperative Purchasing Program Contract #65MCESCCPS ESCNJ 23/24-04, per the attached quote dated February 15, 2024.
- 2. The purchase shall be funded by the Borough General Capital Fund.
- 3. A copy of this Resolution shall be available for public inspection in the office of the Borough Clerk.
- 4. A copy of this Resolution shall be provided to the Borough CFO for information and guidance.
